For the grant of primary school application done, in its reference done verification and in reference to postal transaction by you from June 2015 likely to start primary school, in below private primary Std. 1 to 5 (English Medium) permission is given at the conditions to obey below mentioned conditions.

1. To children of Indian government free and Compulsory Education Act 2009, under its section 19 and 25 standards of the fixed school and measurement should be maintain.





2. Had to obey the verbatim of rules fixed in rule 13 of Children of Indian Government free and compulsory Education act 2012.
3. Have to implement to the norms of management fixed in Gujarat Government Education Department Resolution no. KPS/1011/131/ch Dt. 20/9/2011.
4. Weaker and disadvantaged groups will have to implement the provision of 25% admission in unauthorized primary school by Gujarat Government Education Department resolution no. KPS/102012/72764/Ch. Dd. 23/5/2013.
5. At the time of admission, reservation of any type of payment of fees by the school board or school will not be possible so that the interviews of parents or children can not be taken.
6. The school will not be able to refuse a child for admission to the absence of age proof that neither religion nor the birthplace or place of birth can be denied for admission for one reason, that religion / caste or caste or place of birth can be denied to enter one of the reasons.

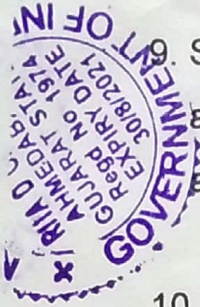


In school admitted any child should not be stopped in any one class till the completion of education. Or shall not get out from the class.

- Any of the teacher of school should not take part in any activity related to private tuition.

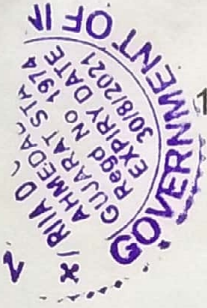
